#### **POSITION PURPOSE**

The position is responsible to the Senior Agricultural Officer (AH&P Central/Eastern) through the ATO (Naitasiri) for the provision of livestock extension services in the Tikina of Waidina/Viria.

#### **KEY RESPONSIBILITIES**

The position will achieve its purpose through the following key duties.

- Provide extension services through effective extension methods such as farm advisory, visits, field days, shows and meetings.
- 2. Maintain liaison with livestock stakeholders.
- 3. Implement all livestock activities in compliance with livestock policies.
- 4. Prepare and implement project proposals for sustainable livestock development.
- 5. Provide veterinary services through veterinary clinical cases and drug sales
- 6. Maintain veterinary drug stock by ordering, recording and reporting drug returns
- 7. Maintain cleanliness of working environment at all times
- 8. Provide regulatory services through animal licensing, dog control and surveillance
- 9. Prepare weekly, monthly, quarterly and annual reports and submission to the supervising officer.
