POSITION PURPOSE

The position is responsible to assist Senior Research Officer- Pasture, in conducting nutritional research trials to address feed and feeding issues for the livestock production system of all livestock Research unit.

KEY RESPONSIBILITIES

The position will achieve its purpose through the following key duties:

- 1. Prepare work programs, initiatives and strategies, budget relating to the functional activities of livestock feed technology.
- 2. Assess, monitor, and collect data of trials, feed and pasture samples for nutritional analysis.
- 3. Propose research activities for generation of improved technologies for dissemination at farm level in all division.
- 4. Monitoring on nutrition status of livestock at Sigatoka Research Station.
- 5. Prepare Weekly, progressively, quarterly and annual report for the station on the performance and achievement of livestock Feed Technology.
- Management of livestock Feed technology unit, assets and staff at Sigatoka Research Station with consultation with SRO Pasture.
